




ONLINE STATEMENTS




On September 1st you will receive a "Registration Confirmation" email from no-reply@ignitefunding.com. If you do not see this email in your inbox please check your junk or spam folders and then contact your Ignite Investment Representative to have this email resent.

This email will contain your Client Login and temporary Password as well as a registration link. Click on the registration link.




You will be taken to the Ignite Funding website which will confirm your registration. You should see the screen to the right.

Next, click on the line of text that says "Click here to Login"



Login using the user name and password that was in the "Registration Confirmation" Email.

When finished click the "Log in" button




The first time you login you will be prompted to change your email from the randomly generated one to a more memorable one.


Enter the password that was in the "Registration Confirmation" Email, then change it to your personalized password.

When finished click the "Change Password" button.


Please note your new password.

Once you have changed your password you will see this screen. Select the "Accounts" option in the top right section



The next screen lists the accounts you have with Ignite Funding. For each account you have the option to view transactions or to view the monthly statement.



The "View Transactions" option will show recent transactions. This screen is updated every two hours with recent postings and can be sorted by clicking on the column heading.
